Export Documentation Focus

Getting Documents Attested

Sometimes it is a requirement that additional export documents are attested - such as invoices, packing lists or Health certificates.

In order for us to attest and stamp these for you, they must be signed by someone who is listed on your companies Formal Undertaking and the signature must be as it appears on the Formal Undertaking

e.g. If your signature appears in full on the Formal Undertaking you cannot just initial the document for attestation.
