Additional Guidance for Exports to Iraq

In addition to circular 831, which we link to below in Export Trade Updates, we would like to give you clearer guidance on the requirements to enable you to export your goods more quickly.

- All Certificates of Origin and invoices submitted for legalisation, must be accompanied by a **Certificate of Conformity (CofC)** or **A letter** from one of the companies below stating that a C of C is not required.
- Not all goods are regulated and therefore do not require a C of C

If a C of C is required it must be obtained from one of the following companies
