Express Applications & End of day cut off time

We would like to remind you of the Express option on the online e-zCert system. This option is the fastest way to get your documents processed and returned to you.

Please note that the Express service cannot be used for CofO's and EUR1 forms for certain destination countries and any documents requiring Legalisation or ATR forms.

Also we would like to make you aware that, unless you have contacted the International Trade Team about your application, any application made after 4.30pm will not be looked at until the following day.
