Process for Certification of "Copy Documents"

You may be asked by your customer to have additional "Copies" of various documents certified by your local Chamber.

Please be aware that we will now be adding an additional 'COPY' stamp to any other documents you request as 'certified copies' that are not already marked as such.

Costs

'Multiple Originals' - each document is charged at the usual rate of £24.50 Members £49 Non-Members + VAT

'Copies' - each document is charged at the usual copy rate of £6 Members £12 Non-Members + VAT
