Getting the best out of your e-zCert account

Using e-zCert is a secure and easy way to raise and apply for your export documentation.

Here are some simple checks to help you get the best out of the system.

- Always make sure you login into your own account and select your own signature. Unless you have the appropriate authorisation letter in place, using some else's account is classed as fraud!
- If your application has been rejected please read the reason carefully and always ensure you have made *all* amendments that were requested to prevent further rejections.
- If your customers' requests multiple originals or copies of your documentation remember you can request these in the 'set up' area of the application.
