### **Virtual Classroom Formats**

Dangerous Goods by Air: There are 2 different types of training for Dangerous Goods by Air.

**Dangerous Goods by Air Revalidation (Refresher)** – This is 4 x 4.5 hr virtual classroom sessions from Monday to Thursday. This is always held on the first week of every month. Learners must hold a valid dangerous goods certificate.

**Dangerous Goods by Air Full** – This is 6 x 4.5 hr virtual classroom sessions from Monday to Friday with Wednesday being a full training day. This is always held on the third week of every month.

This type of training is for anyone that moves dangerous goods and is outside of Lithium Batteries or Infectious Substances or they have batteries but other dangerous goods products.

We can also break this training down into a specific customer need for In-House or Virtual Classrooms e.g. Limited Quantities or Excepted Quantities or for a specific product focus.

### Dangerous Goods by Sea

This is 4 x 4.5 hr virtual classroom sessions from Monday to Wednesday. Wednesday is a full day. This is always held on the second week of every month.

This type of training is for anyone that moves dangerous goods and is outside of Lithium Batteries or Infectious Substances or they have batteries but other dangerous goods products.

We can also break this training down into a specific customer need for In-House or Virtual Classroom e.g. Limited Quantities or Excepted Quantities or for a specific product focus.

### **Combined Sea & Road**

This is 6 x 4.5 hr virtual classroom sessions from Monday to Friday. Wednesday is a full day. This is always held on the second week of every month.

This type of training is for anyone that moves dangerous goods and is outside of Lithium Batteries or Infectious Substances or they have batteries but other dangerous goods products.

#### Lithium Batteries by Air

This is 3 x 4.5 hr virtual classroom session on a Wednesday - Friday. This is held quarterly.

#### **Dangerous Goods Awareness**

It is a requirement of the UK CAA that all employees working in an environment where dangerous goods are transported understand what dangerous goods are and how to recognise them.

This course is hugely beneficial in assisting all employees in recognising potentially dangerous goods that they may come into contact within their work environment. By being familiar with the regulations, labels, and hazard classes your employees can ensure that any potentially dangerous goods that are found; are handled by a certified member of the team.

By the end of the course, you will be able to:

- Correctly identify a consignment that contains dangerous goods.
- Identify the action required if dangerous goods are located.
- List the regulatory parties involved in the carriage of dangerous goods by air, road, rail, inland waterways, and sea.

This course is only an introduction to Dangerous Goods. Certification can only be gained by attending the appropriate Dangerous Goods certification course.

#### **Radioactive Awareness**

It is a requirement of the ONR UK that all employees working in an environment where radioactive goods are transported understand what the different levels of radioactivity are and how to recognise them.

This course is hugely beneficial in assisting all employees in recognising potentially harmful goods that they may come into contact within their work environment. By being familiar with the regulations, labels, and hazard classes your employees can ensure that any potentially dangerous goods that are found; are handled by a certified member of the team.

By the end of the course, you will be able to:

- Correctly identify a consignment that contains radioactive goods.
- Identify the action required if radioactive goods are located.
- List the regulatory parties involved in the carriage of dangerous goods by air, road, rail, inland waterways, and sea.

This course is only an introduction to Radioactive Goods. Certification can only be gained by attending the appropriate Radioactive Goods certification course.

### Low Level Lithium Batteries by Air, Sea & Road

Our low-level Lithium Batteries by all modes training is for employees that work in an environment transporting lithium ion batteries under 100wh or lithium metal batteries under 2 grams. The course concludes with a knowledge test.

This training does not cover batteries transported without the equipment they power by Air. A CAA certification is required to transport UN3480 that is shipped without equipment. For this course see **Lithium Batteries by Air**.



Successful candidates receive a certificate of competence, valid for two years, after which they must revalidate their qualifications.

Low Level Batteries by All Modes Course Objectives:

ESSEX Chambers of Commerce

- Correctly prepare a consignment of lithium batteries for air, road and sea transportation.
- Adhere to the practices and standards required for the transport for low level lithium batteries.

#### This online training course takes on average 12 hours, including Test. The training contains 11 modules. Learners can pause the training and take a break at any time.

Recommended Pre-Requisite if no DG Knowledge Dangerous Goods Awareness

<u>Resources:</u> IATA Dangerous Goods Regulations / ADR Regulations / International Maritime Dangerous Goods Code. If the customer does not have this, it can be purchased. Only 10 days access so purchase should be when they are ready to complete the course.

Our Special Provision 188 by Sea & Road training is for employees that work in an environment where low level Lithium ion or Lithium Metal batteries are handled and prepared for shipping. Our course covers Class 9 Lithium Ion Batteries UN3480, UN3481, Lithium metal UN3090 and UN3091 by Sea and road, under the conditions specified within Special Provision 188. The course concludes with a knowledge test. Successful candidates receive a Sea & Road certificate of competence, valid for two years, after which they must re-validate their qualification.

Special Provision 188 by Sea & Road Course Objectives:

- Correctly prepare a consignment of lithium batteries for road and sea transportation.
- Adhere to practices and standards regarding the responsibilities for the preparation and handling of lithium batteries.

This course deals with the transportation of Iow-level Lithium Batteries internationally. This training supports the need for employers to provide 'Adequate Instruction' to their employees regarding the movement of Section II Lithium Batteries. Successful candidates receive a certificate of competence, valid for two years, after which they must revalidate their qualification.

By being familiar with the regulations, your employees can ensure that any potentially dangerous goods are correctly identified, packed and marked for shipping.

- Correctly prepare a consignment of limited quantities for air transportation
